Dear Vice-Chancellor,

In order to receive consideration by the Advisory Committee, your recommendation should reach the undersigned latest by 30th June, 2013.

Criteria for Eligibility for the Award

- 1. All persons of India nationality regardless of race, caste, religion, creed or sex who have made outstanding contribution in fighting terrorism, violence and promoting goodwill and harmony amongst religious groups, communities, ethnic groups, cultures, languages which would reflect the innate bond of friendship amongst mankind through thought and action will be eligible for the Award.
- 2. Associations, institutions or organisations having a legal status and registered in India who have rendered outstanding service for promoting goodwill and harmony amongst religious groups, communities, ethnic groups, cultures, languages which would reflect the innate bond of friendship amongst mankind through thought and action, will be eligible for the Award.
- 3. Only one individual or one association, institution or organisation may be proposed by a proposer.
- 4. A proposal by person or organisation recommending himself or itself will not be entertained.
- 5. The Award will be given to an individual or organisation for his/its activities in the specified years in the cause of fighting terrorism, violence and promoting goodwill and harmony.
- 6. Associations, institutions or organisations which are exclusively concerned with a particular religion or caste or creed or ethnic group and whose services are exclusively confined to the activities thereof will not be eligible for the Award.
