Issues 1: Is the help desk should be in TNAU campus or the Service provider Locality?

The 24x7 help desk should be in the service provider locality and accessible to TNAU faculty 24x7. A responsible person with contact details should be provided by the service provider.

Issues 2: How often cloud server data should be taken?

At regular point of interval through given output disk.

Issues 3: Shall we avail combination of cloud service providers?

No, Only one service provider has to support all our requirements.

Issues 4: Whether to keep the servers ready for auto scaling?

The existing technical specifications are sufficient for auto scaling and the service provider has to keep spare server capacity whenever needed.

Issues 5: Is the Multifactor authentication necessary?

Yes, Multifactor authenticity is necessary, two factor authentication have to be provided.

Issue 6: What is the procedure for calculating Multifactor authenticity?

The SLA procedure is calculated on annual basis with upstream of 99.99% and the SLA should include two factor authentications.

Issue 7: Will you allow the cloud hosting outside India?

The servers can be hosted and maintained for minimum 3 years compute cloud in India or Asia Pacific region – Singapore/Hong Kong, etc. with CDN in India, preferably in Chennai or Tamil Nadu location.

Issue 8: Who own the commercial OS, database, app license?

The service provider must have licensed version of operating system, database management and application license. Service provider must give 24x7 help desk support, if any problem arises. TNAU should own the commercial OS, database, app license or whatever licenses involved.

Issue 9: Please clarify the 100 Mbps dedicated Internet required?

Yes, It is 100 Mbps with 1:1

Issue 10: Whether the cost of setup, migration, maintenance of hosting supported for 3 years?

Cost includes for set up, migration and maintenance of cloud space for three years.

Issue 11: What is the scope beyond three years?

This tender is part of NADP project for a period of three years time. After three years, it may continue depending upon financial support assured by the Government.

Issue 12: Is there any specific terms of qualification criteria?
