The following issues were raised in the meeting and clarifications were given by the technical committee members to the participants.

Issues 1: Who will take care of further updation of existing database?

The service provider has to take care of the deployment and further updation of the database. Besides, application management which should support the technical specification as mentioned in the tender for three years.

Issues 2: Is there any auditing certificate necessary as like e - goverence tender?

Not necessary. But, the firm concern has to submit balance sheets and auditing statements for the last three financial years.

Issues 3: Who is the responsibility of conversion of web enabled platform?

It is the responsibility of service provider who has to convert the existing crop doctor contents in to web-enabled platform.

Issues 4: Is there any license required for Web enabled platform?

All the softwares should have perpetual license with updation up to three years and supporting the Unicode font of Tamil.

Issues 5: What is the estimated time to complete the task?

It is eight weeks or two months from the issue of supply order.

Issues 6: Whether the open source My SQL could be deployed?

Yes, it could have valid license and any cost in future will have to be met by the tender participating firm concerned.

Issues 7: Whether software should support cross platform?

Yes, the software should support cross machine platform and also cross operating platform.

Besides, a demo of existing Crop Doctor of Paddy was shown to all the members during the pre-bid meeting. The Expert System consists of three components namely, Decision Support System, Crop Doctor and Information System was also appraised to the members.
